JP was planning to complete this scrutiny re sexual and mental health at the end of the month. Havering CAMHS data showed the borough put in more money per case- uptake rates were high. There was no data for how many cases were taken on after assessment- JP was meeting NELFT soon. Schools showed very helpful preventive work.

Sexual health services were needed for Havering.

Transitional Safeguarding draft TOR- the group were happy for the focus to be on 18-25 year olds and their transition to services.
